TERM AND CONDITIONS OF LOCKER USE

1. Locker hire is for a 12-month period (01 May to 30 April of the follow year), or from date of BOM approval of the Hire Application to 30 April of the following year.
2. A locker assigned to a Member will be fitted with a lock supplied by the Club. Members must not remove this lock nor fit any other lock. If an alternative lock is fitted, the Club will remove the lock.
3. The Club is not responsible for items contained within the locker and is unable to guarantee against damage, theft or disappearance. The Member has sole responsibility for possessions stored in the locker.
4. Members must not store any perishable items (food, drinks, etc) within lockers.
5. Members must not store in the locker anything that would be considered dangerous, illicit or a health hazard. This includes; but is not limited to weapons, hazardous materials, illicit materials, drugs or alcohol.
6. Lockers must not be defaced in any manner i.e. stickers, graffiti, keying or scratching.
7. The Club is not responsible for unclaimed or abandoned property from expired or cancelled locker arrangements.
8. The Club reserves the right to inspect any locker without prior notification. Any inspection will be done by a member of the Board of Management or the General Manager, and a Witness.
9. **Declaration:** I acknowledge that I have read the Club's "Terms and Conditions for Locker Use" and agree to be bound by those terms and conditions.
