

# **Branch Director Reports**

**Kye Burke Director Lifesaving** 

The 2018/19 season proved to be a challenging season for operational lifesaving on the SSCB. 340 rescues were completed, with 19509 preventative actions and 8283 first aid treatments undertaken. Of note this season is the number of major incidents occurring on coast beaches. I cannot recall a season so steeped in tragedy, with multiple drowning deaths occurring across the coast. It seemed that at the peak of the season not a week would go by without notification of another resuscitation being undertaken by volunteer or professional services. The after hours and emergency response groups from across the coast deserve a special mention this year with many incidents occurring outside of operational patrolling hours.

This season the lifesaving portfolio took an active approach to member education by facilitating both formal vocational award training through the branch in support of clubs with less training resources, and by the formation of a workshop group delivering operational lifesaving training and content under the auspices of the Rescue Ready lifesaving workshops. Rescue Ready builds on the work done by membership with the PULSE program and looks to complement the content delivered there.

I will be stepping down this season to concentrate on career aspirations and study. I would like to thank the SSC Board of Lifesaving for their assistance over the past few years, and wish the continuing members good luck well into the future. Sebastien de Paula will be stepping into the DOLS role and I have great confidence that his professionalism and knowledge will hold the Board in good stead, continuing to improve upon the operational capability of lifesaving and lifesavers on the Sunshine Coast.

# **Director, Youth and Membership Development**

It's great to come to the end of another fantastic season with great success in membership development again this past year. Our members are our most important asset, so understanding our membership growth and retention is essential to the sustainability of our clubs and the organisation.

Overall, membership in total for the Branch has had a small amount of growth with a 1% increase in active membership, 3% increase in junior activities membership and a 1% increase in overall membership.

Our retention rate across the region sits at 64% - the same as last season, which is over 4000 members we are still turning over each season - a focus on retention will be the key to success in building a healthier and more sustainable membership base in many of our clubs.

## **Development programs**

#### **Camp Commando**

Camp Commando was held again this season at the Sunshine Coast Recreation Centre at Currimundi. Nearly 100 x U14 and U15 participants and more than 25 leaders took part in the program.

One of the new initiatives we undertook at this year's program involved a workshop around youth member retention – the results of this workshop have provided us a great insight into our young members and where we need to put our efforts into the future. Thank you to all of the clubs and their youth development officers who have provided the support to get members along to this program to make it so successful.

Congrats and well done Megan Blin and Aleeshia Chick on leading the coordination team that made the program possible. Well done also to the working group who provided an amazing amount of support: Tara Emery - Dicky Beach, Karlee Bryant - Kawana Waters, Emma Angel - Mooloolaba, and Sam Smith - Dicky Beach. Thanks also to the support crew and leadership team for their amazing efforts as well.

## **Pulse: Advanced Lifesaving Program**

The Pulse program was held at the Sunshine Coast Recreation Centre at Currimundi this season. The program is aimed at exposing members to a range of 'soft skills' that aren't offered significantly as part of other awards. These include decision-making under pressure, situational awareness, and participating in large scale incidents just to name a few. Our expert presenters who are surf lifesavers from a range of backgrounds were again exceptional speakers and were generous in sharing their knowledge and experience.

Congratulations and well done to the coordination team who made the program a huge success. Thank you to Megan Blin - Kawana Waters, Eliza Dreves - Met Caloundra, Trevor King - Noosa Heads, David Scullion - Mooloolaba, Tara Emery - Dicky Beach and Aleeshia Chick - SLSQ.

# **Lifesaving Development Program**

Through the State Membership Services Committee (MSC), this program which is run by Surf Life Saving Tasmania was identified as a potentially positive initiative for supporting young members in gaining awards. The program is a week-long, live-in program that sees members gain a number of awards through scenario-based training. The Sunshine Coast Branch offered to trial this program in conjunction with MSC, and the results were hugely successful. With a coordination team comprising members from the Sunshine Coast, Gold Coast and Tasmania, 19 participants from both the Sunshine Coast and North Queensland successfully completed the program with overwhelmingly positive feedback.

The benefits of this program are far beyond just gaining awards. Participant skills development included leadership, team work under pressure, how to deal with scenarios during and post incident, and how to integrate with other emergency services. The leadership team also gained new skills including how to prepare scenarios, scenario make up application, and debriefing.

We are now looking to not only run this program again on the Sunshine Coast but working with MSC, looking at how we can support it being run in other branches.

Thank you and congratulations to the coordination team, leaders and trainers who delivered this program. Special thanks to Narelle Souter and Aleeshia Chick for your outstanding work and dedication in making this inaugural program for Queensland a reality.

#### **Youth Ball**

Youth Ball was held on the last weekend of the season this year which was new timing and worked well. It was held at Kawana Surf Life Saving Club with 120 young members coming along to celebrate the past season and to recognise the efforts of our youth members. Due to timing we couldn't present the awards of excellence youth awards so instead presented a 'Valuable Member Award' for one member of each club to recognise their dedication to leadership, teamwork and commitment to their clubs during the past season.

The success of the above programs is only possible thanks to the support and commitment of our clubs. There continues to be some innovative work done by club Youth Development officers. Well done to all of you on your efforts in encouraging and supporting our young members.

# **Junior Activities**

Our Junior Activities programs have had another positive season with clubs continuing to improve how they deliver these programs and the standards of safety and sustainability in place. Congratulations and thank you to the JACs for their work during the past year. Running a junior activities program is a significant undertaking and your work in looking after our young members throughout the season is greatly appreciated. I would encourage all of our JACs to continue to provide feedback throughout the season on how junior activities policies and procedures can be improved to ensure we get the best out of our youngest members of the organisation.

We have been lucky enough to celebrate a significant milestone this past season with 50 years of Nippers in Queensland – what an amazing achievement for Surf Life Saving.



Our patrolling members have completed an incredibly successful Life Saving year in some testing conditions. There were months of large seas, which created permanent rips and currents week after week. I sincerely congratulate all of our Club's patrolling members for ensuring that 'No Lives Lost' record during 91 years of patrolling beaches in Noosa remains intact despite the many, many rescues, sometimes in treacherous conditions. This includes all of the beaches the Club patrols including Noosa Main Beach, Noosa West Beach, Peregian Beach, the Noosa River Mouth and Laguna Bay from the North Shore across to the National Park. I again thank all patrolling members, including those who also volunteer on the waverunners, for your unwavering commitment to ensure that both our community residents and visitors, including many thousands of international tourists, have been able to enjoy all of our beaches in safety. I can assure you that this outstanding and vital effort has yet again, not passed unnoticed by the Club's Life Members, our Sponsors, the Sunshine Coast Branch, Surf Life Saving Queensland and the Noosa Shire Council and many other community organisations including Tourism Noosa. Your efforts this season have been outstanding ... so I sincerely thank and congratulate you.

Club Captain, Roger Aspinall, and his Life Saving Committee worked constantly throughout the year to keep patrols up to strength and encourage Patrol Captains to challenge and involve their younger patrolling members more including upskilling them. For the continuous and vital support provided to our life saving members by Club Trainers I commend and thank CTO Paul Jenkinson, Education Manager Greg McLaughlin (now retired) and Greg's replacement, Jonathan Donnelly, all trainers and assessors whose commitment ensures our high record of training is maintained. This also includes the IRB driver and crew trainers who have endeavoured to put many more drivers and crew members through these courses. The Surf Education and Awareness Program has continued to grow and now exceeds some 40 schools and 7000 students. This program delivers an unmeasurable benefit to our community and families, although as a Club, we absolutely believe the benefits are enormous.

The JAC (Nippers) has had another excellent year under the leadership of Director Steve Tindal. He and his committee had in excess of 800 nippers this season (Noosa and Peregian) to look after, educate, train, coach and organise. The Peregian Nipper Program was launched and with the support of the new community group, PFAFA, ensured it was a great success with up to 120 new nippers. Club members and nipper parents Leigh and Rob McCready have been a driving force behind the scenes, encouraging Peregian parents and children to become involved and encourage them to assist where possible. This was also driven by a very committed JAC Peregian Co-ordinator, Lyndon Forlonge, who along with Director Peregian Brett Leckie, ensured all planning, water safety and Sunday sessions went extremely well and that parents were involved to assist and, in a number of cases, train up to become SRC's (Surf Rescue Certificate holders) or Bronzies (Bronze Medallion holders). Again, I had the pleasure of assisting with the selection process for next year's Nipper Club Captains and Deputy Captains and the standard of the young people who voluntarily applied for these positions were outstanding and impressed all of the panel and I congratulate all of these members. On Anzac Day a wreath was laid at the Tewantin Service by our Nippers Captains and Vice Captains from both last year and this year, James and Zoe along with Millie and Tom and deputies Poppy and James and we thank them all. The Seahorse Nippers held two very successful and popular programs in September 2018 and April 2019 and both were well attended. With setup and parking support mainly by Peter (Big Pete), Kenny, Greg, Donald and Craig plus the smoothie crew, the program ran wonderfully under Steve, Nikki and Lorna's guidance and the Club is forever grateful to all the members who assist. The additional support provided by new administration members including Sacha under JAC and Renee who is the new Club Youth Development Officer, proved invaluable to successfully running these programs including development and retention of members.

Sponsorship has once again increased this year with sponsorship income exceeding budget. This has resulted in many more vital pieces of rescue equipment able to be either ordered or replaced before the next year's budget. This in turn will decrease the load on the expenditure next year and where required, will allow any additional items of equipment to be considered for purchase. Some highlights include two new sponsored Surf Boats. One from Richardson and Wrench Coolum and Noosa and the other from Devcorp, a Brisbane based development company. Devcorp is owned by Murray Thornton who has children in Nippers and who himself rows in one of the Club's Masters Boat Crews. He wished to give something back to the association he loves and joined, in his youthful years at Batemans Bay, NSW. There were two very successful Sponsors' breakfasts held during the year to communicate their importance to the Club and the equipment that their vital support provides.

Our youth were in focus along with some incredible and solo rescues that put some members' lives at a very high risk and the Club's Junior Captains were presented to the attendees. These included; Federal MP Llew O'Brien, Noosa Mayor Tony Wellington and Tourism Noosa CEO Steve McPharlin (also a Nipper parent). The Junior Captains introduced themselves and I congratulate them for a wonderful job.

Director of Finance, Craig Moore, has continued to ensure that the budgets remain on track and constantly delivers detailed financial reports at Board and General Meetings. This year Craig again presented a Budget Forum prior to the AGM where all members were encouraged and invited to attend to receive information or ask questions on the budget. All the Directors play a significant role, following their budget expenditure and were either on track or under budget at the end of April. With the support of Sharon in Finance Administration, financial reports are delivered as required in a very clear and precise manner. The Directors have all contributed enormously to operating the club on your behalf, attended Board meetings where possible and have all been vigilant in following the strategic plan with enthusiasm. It has again been a pleasure to Chair the Board Meetings with the Directors continuing to offer positive input for the future Strategic Planning for our Club. For strategic reasons the Board is now looking to increase the amount of space off site and available to the Club for additional storage of vehicles i.e. bus, trailers, equipment and craft and possibly an area that could include space for maintenance and repairs. The existing facility offsite is full and has no outside secured space for trailers or vehicles. This could in turn be sold or leased to provide a steady income for the future. At the previous General Meeting in April, the members approved, in principle that the Board continue to investigate all options with the intent to purchase another facility. Any necessary funds are available from its investments and no loan would be required. The Club now has some 12 trailers for surf boats, IRB's, carnival craft trailers, nipper trailers and a seahorse nipper's trailer that is constantly full of equipment for the program to run twice a year.

The Bursary Program for our youth was advertised to all members and the response was exceptional with double the numbers from across the club compared to last year, applying for a Bursary. In response to this and for the second year running, the Board recommended to the Club Council that the funding for it was increased to ensure that no eligible member either missed out or did not receive a reasonable amount of bursary funding to assist with their education, training or other expenses. All funding is only distributed on receipt of legitimate receipts after patrol hours and other club commitments are reviewed during the season. I thank the appointed Bursary Review Group for their time spent on this very positive program.

To ensure a stable financial platform for lifesaving the Surf Club has the fantastic Supporters Club upstairs. The Supporters Club has continued to grow each and every year since the rebuild some 10 years ago. Due to the high usage and constant exposure to all weather conditions the Club carried out an extensive renovation program to breathe fresh life into the facility. This renovation included a new entrance and reception, bar, ceilings, Board Room, staff facilities, Manager's office and smoking area as well as opening up the west end of the Club and also installing bifold windows to the outer deck. General Manager, Anton [Moggy] Mogg, and his Operations Manager, Les Evans, worked over and above and tirelessly ensured as little inconvenience possible to all members and Club patrons. The result was that the bar was closed for only 15 days and turnover, although overall, a little lower, was soon made up as the renovations continued through until completion. To top it all off and for the second year running, the Club won the Best Supporters Club on the Sunshine Coast and when the renovations are considered that commenced in April and ran through until Christmas, it was a fantastic achievement by Moggy and his Team. Then in March the Club hosted the TV show 'Master Chef'. Due to beach conditions and the inability for marquees to be erected on the beach, a decision was made by Moggy to host it on the deck and the Club was made available to the producers of the show. It was a massive success, more than covered financially and it was exciting to see this aired during an episode of Master Chef in June, another great initiative by Moggy and the Team, so our congratulations to all involved. At last year's Supporters Club AGM Life Member Lenore Grice was elected to the position vacated by the long serving Board member Ron Lane. More recently, the long standing Secretary of the Supporters Club Board, Ian (Macca) McDonald suffered a sudden and very severe illness. Sadly, Macca, who was also a patrolling Radio Officer, passed away during April. Macca loved nothing more than a good 'stir' and in particular when it came to any smoking discussions and/or a coffee shop. He may be gone but he will not be forgotten. In the interim, Past President Greg Cowie accepted the invitation and was appointed to fill the position of Secretary of the Supporters Club until the AGM. Life Member Phil Cave, who was actually 4 years older than the Club when he turned 94 in September last year during the Club's 90th Birthday left us in February after a short illness. It was fitting to have Phil in our company and able to enjoy our 90th and of course the video interview of Phil remembering life at the Club in the late 40's and 50's was simply wonderful and memorable. I thank Peter Taylor from Noosa Beach Hire for creating and donating this interview and reflection of Phil, to the Club. Later in March when family from overseas were available, Phil's ashes were scattered in Laguna Bay, off First Point. The Surf Boat section paid tribute to him by launching the three boats [one had been named after him] and as I was scattering the ashes and saying a few words to honour Phil, they all raised their oars as a salute, so I say thank you to the rowers and sweeps for ensuring a fitting tribute to Phil and it was extremely well received by all family members.... a very special moment.

As the Club continues to grow older, it is only natural that members are recognised for their ongoing commitment and dedication to the club and nominated by members for the esteem award of Life Membership. This year I have had the honour of announcing three new Life Members and in order of nomination are Greg Cowie, Peter French and Gerard O'Brien. The nominations of these three talented gentlemen were all received and successfully approved by the Life Membership Panel, the Board and finally by the members at a General Meeting. Both Greg and Peter joined the Association in 1995 and Gerard in 2001. They have all been Patrol Captains over many years and served with distinction on the Club's Board in various positions including President, Deputy President, Director of Administration and Director of Surf Sports. It is also very significant that on entering the Association they did so as Nipper parents and reinforces the importance of the Nipper program and retention of our members into the future. As I had been the previous last member to receive the honour of Life Membership nine years ago back in 2010, it was extremely pleasing to, now as President, officially bestow these Awards on these gentlemen and I, again on your behalf, both thank and congratulate them for their commitments to our Club and the Association over their combined 67 years of service.

Surf Sports has again conducted a very successful year with many outstanding achievements. However, to mention a few that I believe are special, are the achievements of the First Aid Team and in particular both Lara Porter and Lily Tindal who under coach Lenore, not only won Australian Gold in both U17 and U19 division, but also won Silver Medals in the Open Competition. Then there was the Surf Board Riding Team under coach Kirsty, who not only won the overall points score for surf board riding at the Australians, but secured medals from Gold to Bronze including winning the Open Team event to round off a fantastic competition. Finally, although our young female and male U19 surf boat crews did not medal at the Australians, their efforts throughout the year have been exceptional and have stamped their presence at every carnival from NSW to QLD and earned the respect of all boaties throughout the country. They are wonderful young ambassadors for not only the sport but to younger [and even older] members of our club and will be seen at early morning training, assisting with Seahorse Nippers, patrolling and water safety at water events on our beach. To me they have breathed life into our boat section [sorry masters] and thanks must go to their coaches Dave and Mick for their guidance and mentoring ....well done.

As the Club continues to grow, across the board, the load on the administration increases proportionally. General Manager Byron Mills continues to ensure that even in difficult situations, staff levels are maintained to keep abreast of any requirements and within budget. Whilst there were some staff changes during the year Byron ensured that other staff were allocated various shared roles to maintain administrative functions. Hannah has become the new Administration Manager and Sharon moved back to Finance Administration, a role she had performed previously. A new position, planned for in the Strategic Plan, was advertised last year and Renee Scully from WA was appointed as the Club's Youth Development Officer. Her main and vital roles are retention of our youth, visiting schools to encourage young people into joining the association and ensuring that the Club is a happy place for the youth. To date Renee has delivered wonderful enthusiasm to the role and started up new programs for all our youth. Director of Administration Barry Leek worked tirelessly to ensure that all efforts were made to support our Club's administration and Club Council meetings as per constitutional requirements. This commitment by Barry often goes unnoticed but he is always available and willing to assist members at any time. I also mention that he was named as the Qld Official of the Year at the Qld State Awards last year. Past President Gerard O'Brien was elected as Branch Deputy President last year and will step up to President this coming year. With his experience and dedication to the Association he will deliver numerous benefits to Branch and we congratulate him and wish him well for the future in this vital role.

In concluding I wish to acknowledge the considerable support I have received from all Board members and particularly my Deputy President Rob Harney. Rob is always available to assist at any time regardless of the timing and follows through any actions or tasks he receives for the club with efficiency and enthusiasm. I also acknowledge the support received from our governing bodies being both Surf Life Saving Queensland and Sunshine Coast Branch. Our relationship continues to be a very strong and stable, one built over many years of trust and communication between us all. The Noosa Shire Council is also always ready to communicate and support any activities we have at Noosa Beach and we thank them also.

So 2019 has come along at last, after a big lead up its great to now formally be able to celebrate 100 years of our volunteer lifesavers keeping Coolum Beach safe. If Jack Morgan could see today what he started on Easter Sunday 1919 he would be both amazed and very, very proud.

As our clubs vision statement says Coolum Beach SLSC has been the heart of Coolum for all of those 100 years and as their current President I am very proud to be a small part of the iconic legacy that has been created.

As Coolum has grown and developed over the years the club has changed, the people have changed but one thing that hasn't changed is the beach and our "strong beating heart of tradition", the need for you, our members, to protect all those who want to enjoy a swim at one of the most beautiful beaches in Australia.

This year not only do we celebrate our centenary but it is 50 years since Nippers was introduced into the lifesaving movement. Here at Coolum we had an enthusiastic bunch of kids called the "Coolum Darts". Back then we had only a handful, today we average 200-220.

There have been some significant movements this year, first being the purchase of a new 2½ acre property at the back of Coolum. This property will be used for the storage of club equipment. At the moment the construction of 480msq under roof shed is very close to completion. A modest refurbishment of the existing clubhouse is also near completion focusing on member needs in delivering real assets and improvements to the club for all the club members to make the club more functional and better to enjoy.

Also of significance is the progressive and innovative foresight of our biggest supporter our Supporters Club. This year has seen the introduction of a very successful courtesy bus as well as some light entertainment on the weekends. One of the big environmental moves they have made this season is the installation of approximately 200 solar panels which has reduced the clubs reliance on the grid by 20% or more. Furthermore the existing 42 panel system that was already there will be reinstated on the new shed on our second property. What our general membership base probably doesn't know is the Supporters club has made contributions to the Lifesaving Club to pay down the debt on the second property by approximately 40% already.

As I look back on the season I reflect on, and am very proud of, so many members that have put in extraordinary efforts this season in all areas of the club. I won't single anybody out because I can't, from the Centenary Committee to the Nippers Committee, Surf sports, Competitors, the Lifesaving Committee, Facilities Committee, Administration, Club Officers, Officials and, last but by no means least, you the person who puts on the red and yellow and sacrifices your time to stand between our flags to keep others safe. It's what we have been doing for the last 100 years and no doubt will be doing for the next 100.

Also thank you to all other Life Members who have contributed throughout the season, to every Member and Supporters for their work at our surf carnivals, gratitude to our coaches for the time taken to train and mentor our competitors, and a big thank-you to every trainer and assessor who gave their time to upskill and educate our new and existing members.

Our membership is broad and diverse, and everyone plays a key role – from doing patrols on our beach, fundraising, coaching our members, water safety for our nippers, officiating, administration, training and assessing members for competence; and providing operational support during rescues and searches.

Members understand the importance of 'vigilance and service', and how many rescues are avoided through the early intervention and preventative actions of our patrolling members.

Finally, thank you to every member who participated on a Club Committee or Board, your representation of our membership is vital for continued success.

Our highlights of the season started on the 22nd of September with the first day of patrol starting and the opening of the Robbie Thomasson room that afternoon, and two weeks later the Matty Barclay room.

The Senior Room is named after Robbie Thomasson one of our Great Champions from the 1990s. Robbie joined Maroochydore SLSC as a Cadet in 1989-90 season, from Central Queensland. Coached by his father Cyril, Robbie won the following prestigious Australian Surf Lifesaving Championship Gold Medals; 1993 Under 18 Ironman Championship, 1994 Open Taplin Relay Championship, 1996 Open Surf Race Championship, 1996 Kellogg's Nutri-Grain Ironman Series Champion. Robbie tragically died in a car accident only 5 months later, in August 1996. Robbie will be forever remembered for his Black Swan 'Loyalty, Guts and Glory'.

The 'Matthew Barclay Room' is the name of our Youth area, remembering another young Champion of Maroochydore who had been part of our Junior Activities group for many years. Matty Barclay joined Maroochydore SLSC Nippers in 2009-10 season. From the beginning Matty impressed as a young lifesaver and athlete of exemplary character. In 2010 Matty won the Under 12 Surf Race at Nippers State Titles. At the 2011 Aussies, Matty became our then-youngest Aussies medallist earning Bronze in the Under 15 Male Surf Teams at the age of 13 years and 5 months. Matty died in Aussies competition on 28 March aged 14 years and 5 months. Matty is greatly missed and forever young. Matty made his short life wide.

Our competitive team result at the World Titles held in South Australia, where the Club won the under 19 World Championships.

Aussies – placed a credible 4th with a very small team mainly made up with our youth winning 12 Gold medals.

Tiarnee Massie, Adam and Matt Palmer Qualified for the Nutri-Grain Series.

The celebrations of the 50th anniversary of the nippers in the Club New Olympian Board on the second floor near the steps.

## **Improved Club Facilities**

A number of improvements have been made over the season; including the renovation of the Youth Room and the opening of a Senior Room for the enjoyment and use of these member groups.

Installation of new air conditioners and an improved extraction system to Male and Female dorms and bathrooms has greatly improved these facilities. Members who stay in the dorms are finding the upgrades a great improvement.

New doors to the beach, new boat and ski rack, new racking for IRB storage.

A bank of member lockers was purchased and installed in the breezeway so members could keep their belongings in a safe place, secure when they were patrolling or enjoying club activities.

A commercial coffee machine was purchased for the canteen, and every Sunday morning JA Volunteers are pumping out coffees to keep our members going.

On the recommendation of the Club Auditors expenditure was set aside to update and expand the security systems and more CCTV's have been installed, as well as an upgrade of the Club's IT server. Replacement of the 15-year old phone system has been made, and the new phone system as a number of automated enhancements.

In May, work is being done to repair the southern awning outside the lady's toilets/dorms where water has damaged the support beams. Also, construction of lunchrooms and offices for the Supporters Club staff has commenced. It is expected to take 2-3 months to complete this work.

As a club we successfully held two Carnivals - Rebel Sports Junior Activities Carnival, and Murphy Homes Maroochy Classic Youth and Open Carnival. These were a great success through the dedication of our tideless workforce.



# Notes to the Financial Statements

# Surf Life Saving Old Sunshine Coast Branch Inc For the year ended 30 April 2019

#### 1. Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act (Qld) 1981. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of this financial report.

# Income Tax

Pursuant to the Income Tax Assessment Act 1997, the association is exempt from paying income tax to the Commonwealth Government as it is a non-profit sporting entity.

# Property, Plant and Equipment (PPE)

Plant and equipment, motor vehicles, driveways, ramps and buildings are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

# Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income and expenditure statement.

# **Employee Provisions**

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

# Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

#### Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

#### Investments

Investments held are originally recognised at cost, which included transaction costs. They are subsequently measured at fair value which is equivalent to their market bid price at the end of the reporting period. Movements in fair value are recognised through the statement of financial position.

#### Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

#### Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

#### Leases

Leases of PPE, where substantially all the risks and benefits incidental to the ownership of the asset (but not the legal ownership) are transferred to the association, are classified as finance leases.

Finance leases are capitalised by recording an asset and a liability at the lower of the amounts equal to the fair value of the leased property or the present value of the minimum lease payments, including any guaranteed residual values. Lease payments are allocated between the reduction of the lease liability and the lease interest expense for that period.

Leased assets are depreciated on a straight-line basis over the shorter of their estimated useful lives or the lease term. Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are charged as expenses in the periods in which they are incurred.

#### Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

#### Revenue and Other Income

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.
