BY-LAW NO. 10

SUBJECT:	DISPLAY OF MEMORABILIA, AWARDS, TROPHIES & CITATIONS
COMMENCED:	DRAFT – NEW BY-LAW

1. DISPLAY OF MEMORABILIA, AWARDS, TROPHIES AND CITATIONS

- (a) This By-law applies to the display of Memorabilia, Awards, Citations, Trophies, and photographs of Club Members, individuals or organisations who have offered auspicious service to the advancement of Maroochydore Surf Life Saving Club and Surf Life Saving activities in general;
- (b) Designated display areas will be determined by the Board of Management in consultation with the Club Historian. The Board will determine the particular location for the display of each item within designated areas;
- (c) Donated Memorabilia, Awards, Trophies and Citations will be accepted by Maroochydore SLSC with the donor's full agreement that the Club has the right to display or dispose of the items at its discretion;
- (d) Items given by individuals should have affixed to the back, a label with the Donor's name and his or her address so the Donor can be contacted if the Club wishes to change or remove the displayed item;
- (e) The Board of Management will reject any items for display that promote political, religious or commercial interests;
- (f) The Club is not responsible for the theft, damage, or fading of items displayed.

2. DISPLAY CABINET

- (a) The glass display cabinet located in the Club foyer is available to display items of Club lifesaving memorabilia that may be of interest to, provide information to and give enlightenment to the local community and general public;
- (b) Items selected for viewing in the foyer display cabinet will be recommended by the Club Historian to the Board of Management for their approval.

3. DISPLAY OF PHOTOGRAPHS

- (a) Photographs of Australian Championship winners (including Masters Competition and the Australian Youth Championships) may be displayed in the Club Foyer as follows:
 - (i) In colour accompanied by the details of the Member or Members and the relevant title or titles won;
 - (ii) By one photograph for all titles won in each specific age group.
- (b) Photographs of Life Governors of the Club shall be displayed in the Board Room;
- (c) Photographs of Life Members shall be displayed in the top level of the Club premises;

- (d) Photographs of Members who receive Australian Honours Awards for services to Surf Life Saving, bravery rewards or other special awards may be displayed;
- (e) Photographs of Junior Activity Members who win Junior State Championships may be displayed in other parts of the Cub premises;
- (f) In the event the space available to display the photographs referred to in 3(a) (e) becomes insufficient, the Board of Management in its absolute discretion may determine that some or all the photographs be removed to allow for more recent photographs to be displayed;
- (g) Photographs of the following may be displayed in other parts of the Club premises if sufficient space is available:
 - (i) State Championship winners (not including Junior Activity Members);
 - (ii) Australian and Queensland State representatives;
 - (iii) Other Club members;
 - (iv) Other people or items associated with the Club.
- (h) All photographs displayed within the Club premises shall be reviewed each year prior to the commencement of the patrol season by the General Manager and the Member or Members authorised by the Board of Management to ensure their continued relevance and accuracy;
- (i) Images of Members referred to in 3(a)-(g) may also be displayed by electronic or other means in such other parts of the Club premises as the Board of Management may decide.

4. DISPLAY OF HONOUR BOARDS

- (a) Honour Boards or other forms of recognition may be established to record the following:
 - (i) Life Membership of the Club;
 - (ii) Members who hold a position on the Board of Management in the current season;
 - (iii) Members who, then being active in the Club, gained selection represent Australia as an Olympian;
 - (iv) World Championship winners;
 - (v) Outstanding Club competitors on a yearly basis;
 - (vi) Male and Female Most Outstanding Members and/or Club Persons of the Year;
 - (vii) Patrol of the Year; and
 - (viii) Other achievements or recognition of Members as may be determined from time to time by the Board of Management.
- (b) Honour Boards shall be displayed within the Club premises subject to suitable space being available;
- (c) If necessary, the details of individual Honour Boards may be combined at the discretion of the Board of Management so that sufficient space is available to facilitate the display of club photographs and member achievements;

(d) While every effort will be made to display all relevant photographs and Honour Boards, the Board of Management may exercise its discretion to determine that one or more items will not be displayed. In exercising its discretion, the Board of Management is to ensure that priority is given so that the matters referred to in clauses 3(a) - (d) and 4(a)(i) - (ii) remain on permanent display.
